

Advanced Completer Satisfaction Survey Results

The state of Mississippi has a common survey for satisfaction of employers and completers of advanced programs. This was sent to all completers with one year of experience since completing their advanced degree and to those with three years of experience since completing their advanced degree for the first time in 2020 statewide, along with their employers. The response rate was low for the first administration. The survey results below indicate the survey sent in the year 2020 for first (2019) and third (2017) year completers.
