Advanced Completer Satisfaction Survey Results

The state of Mississippi has a common survey for satisfaction of employers and completers for graduate programs. In 2020, the state sent the survey for the first time to completers who completed the graduate program one year ago and to those who completed the graduate program three years ago, along with their employers. The response rate was low for the first administration. This could be attributed to the Covid-19 crisis as this survey was sent out in March 2020. The survey results below indicate the survey sent in the year 2020 for first (2018/2019) and third (2016/2017) year completers. Results were combined for 1st and 3rd year completers due to the low N. Measures are being taken to increase the response rate so that separate reports can be shared for 1st and 3rd year completers.
