

SATISFACTORY ACADEMIC PROGRESS

- _____ I understand that a copy of the complete policy on Satisfactory Academic Progress is available to me upon request.
- _____ I have read and understand the satisfactory academic progress policy for the purpose of receiving financial aid at **Delta State University**.
- _____ I understand that, should I fail to maintain minimum standards set forth in this policy, even though I may be readmitted to the university, I will **NOT** be eligible to receive financial aid unless I am reinstated as outlined in the policy statement.
- _____ I understand that if I withdraw, officially or unofficially, from school during a semester in which I am receiving financial aid, I am **NOT** eligible to receive financial aid the next semester I attend Delta State.
- _____ I understand that students who receive financial assistance based on full-time enrollment (12 hours or more), but successfully complete less than 12 hours or withdraw from school will be placed on financial aid hold/suspension. **W's, F's, and I's are not considered successful completions.** I understand I do have the right to appeal, but that this appeal does not guarantee that my financial aid will be reinstated.
- _____ I understand that financial aid is not awarded for **audits**; therefore, a student may be required to repay any financial aid awarded for a course that is changed to an **audit** at a later time during the term if that change results in the student's enrollment being less than full time.
- _____ I understand that federal regulations require that a student complete the requirements for one undergraduate degree within a 150% time frame. For purposes of monitoring satisfactory academic progress within this 150% period, we have assumed that 130 hours are required for an undergraduate degree; therefore, 195 hours attempted would constitute the maximum allowable hours in pursuit of an undergraduate degree. Aid may be granted for up to 195 hours of course work provided those courses are required for completion of a degree and the student remains within 195 hours attempted.

STATEMENT OF ALLOWABLE CHARGES

- _____ I understand that students admitted to Delta State University in the Over 21 program **ARE NOT** eligible to receive any financial assistance until they have successfully completed at least 12 approved credit hours with at least a 2.00 grade point average. Additional information about this program can be obtained in the Admissions office.
- _____ I understand I may be offered federal student loans. I understand I have the right to decline or reduce any loans offered.

INSTITUTIONAL SCHOLARSHIP POLICY

Institutional, foundation, federal, and state funded scholarships and grants are all subject to a maximum yearly amount not to exceed the actual cost of tuition, average room & board charges, and a \$300 per semester book allowance.
