I, the undersigned, hereby agree to the following:

1. I am voluntarily participating in the 2014 Kappa Delta Shamrock event at Kappa Delta Sorority, Gamma Psi Chapter at Delta State University (hereinafter referred to as “Kappa Delta.”) I recognize that participation in the 5K event requires physical exertion, and I am fully aware of the risks and hazards involved and the rules involved in the event.

I understand that I may be asked to forego participation, if it is believed that I am impaired in any way and unable to participate.

3. In consideration of Kappa Delta’s permitting time to participate in the event, I hereby agree to the following conditions:
 - a. I assume full responsibility for any risks, injuries, or damages, known or unknown, which I might incur as a result of the participation in Kappa Delta’s event.
 - b. I knowingly, voluntarily, and expressly waive any claim I may have against Kappa Delta Sorority, Inc., Gamma Psi Chapter of Kappa Delta Sorority, Inc., Gamma Psi Parents Club, Gamma Psi House Corporation, and Gamma Psi Chapter Advisory Board and their officers, agents, employees, for any injury or damages sustained whatsoever as a result of participation in Kappa Delta’s event.
 - c. I agree to abide by all other terms and conditions required for participation in the event as they may from time to time be posted, amended, or augmented, including attending an orientation session to familiarize myself with the proper rules and regulations of the event.
