The artist and his/her legal guardian understand that MAET shall not withhold from the compensation payments any federal or State unemployment taxes, federal or State income taxes, Social Security tax, or any other amounts for benefits to me. Further, artist and his/her parent or legal guardian understands that MAET shall not provide any insurance coverage or other benefits, including Workers' Compensation.
