04) Guest Speaker – Dr. Myrtis Tabb, Associate Vice President for Finance & Administration shared the agenda for the "Winning the Race conference" here on campus March 30th-31, 2015. She encouraged us to attend, bring our students and noted that the conference is being funded by outside entities.

05) President's Report – President Hebert shared the importance of letting your dean/chair as well as the DSU Foundation, Keith Fulcher if you are given sponsorship/funding for any DSU function or event. So that everyone is in the know. President LaForge was provided a 4 year renewal contract from IHL. The legislature has passed the IHL salary increase for the 8 universities and the bill is said to be on the governor's desk. President Hebert encouraged us and our colleagues to complete the surveys for administration – Dean, Dr. McAdams & President LaForge. We need a good turnout. These survey results are viewed only by the past president, current president and the president elect of the senate. President Herbert states that he will be sharing a copy of a letter from the Faculty senate Leadership of the 8 universities have penned for the legislature, Lt. governor and the Governor about the 5% funding bill for raises. He also stated that due to the FY 2016 Mississippi economic numbers we will need to be extra cautious about spending monies immediately as they have been over projected and we do not need a change that may require us pay back monies as we have had occur in the past.

President Hebert presented several possibilities to provide the fairest mechanism for everyone employed at DSU. There were questions and answers discussed about Market vs Merit. The proposed salary plan is for 4 years.

The faculty senate recommends that faculty, staff, and students to have a priority over the community.

6. Student Evaluation of course and faculty – This evaluation has been updated for this semester. It now has 13 Questions with the Question about the bookstore having been moved to last and will be reflected in faculty rating scores. Neutral has been moved to the end instead of in the middle and a comment box is included.

7. Syllabus request by students- SGA has requested the syllabi be standardized. Discussed the need to develop policy of requirements for syllabi – required to refer to a summer workgroup and have the President sent out any current and new policies about syllabi requirements.

8. Officer Request for coming year – Be thinking about new officers for next year's Senate. Will be voted on at the next meeting on April 9th.
