

## DSU'S INSTITUTIONAL MISSION

The MBA is essentially a generalist degree that touches on all aspects of the business environment.

## WHAT IS REQUIRED FOR ADMISSION?

There are two levels of admission to graduate study:

- 1) Admission to the University
- Admission to the degree program (Admission to the University is a prerequisite for admission to a degree program.)

## To be eligible for admission to the University the following requirements must be

## the following requirements must be met:

- An applicant must hold a baccalaureate degree from an accredited institution.
- ◆ An applicant must have an undergraduate background appropriate for the graduate study proposed.
- ♦ An applicant must be eligible to reenter in good standing the last college or university attended.
- An applicant born after January 1, 1957 must present proof of immunization for measles and rubella. Medical exceptions to this policy are described in the General Catalog, a copy of which is available upon request.

## Admission to the MBA degree program requires the following prerequisites:

Completion of 30 semester hours consisting of the following:

- ♦ Financial Accounting I
- Managerial Accounting
- ♦ Microcomputer Applications
- Macroeconomics
- Microeconomics
- ♦ Management Principles
- ♦ Business Finance
- Marketing Principles
- Statistics

## Other prerequisites include:

- Applicants lacking a business degree will be required to take the MBA Foundation Module below and earn at least a grade of "B" in the Module.
  - MBA 515 Managerial Accounting & Finance
  - MBA 525 Management Theory /Business Law
  - MBA 535 Theory of Economics/Marketing
  - MBA 545 Statistics/Information Systems
- Applicants must have a 3.25 (Scale of 4.00) overall undergraduate GPA or have at least 4 years of professional or managerial work experience or earn an acceptable score on the Graduate Management Admission Test (GMAT).
