

DEBTS PROGRAM at Delta State University's College of Business

The Debt Education for Business Transformation and Sustainability (DEBTS) Program initiative at Delta State University is an intensive program that will use a combination of technology (iPads and webinars) and face to face visits to provide credit and debt management training and repair services to current and potential micro-entrepreneurs. The program will focus on entrepreneurs located in Bolivar, Washington, Sunflower, and Coahoma counties. The DEBTS program is a three year program where 12 micro-entrepreneurs will be recruited each year to the program with participants from each county. Each participant will attend eight training workshops and have a minimum of two consultations per month.

The methods for this project will include the collection of primary and secondary data, evaluation of the collected data, development of a "best practices" program based on the conclusions drawn from the evaluation, promotion of the program to micro-entrepreneurs, and implementation of the program to assist in the education of and technical assistance to disadvantaged micro-entrepreneurs.

MISSION

To provide credit and debt management training and repair services to current and potential microentrepreneurs located in Bolivar, Washington, Sunflower, and Coahoma counties.

DEBTS Program anticipates saving 120 to 180 jobs as well as creating 40 to 60 jobs as a result of the program.

VISION
