 - Item passed unanimously
- <u>Designated Delegates</u>: (amendment 2) Shall be either the Director of a department or a staff member of the department who is appointed by the Director to serve a <u>one-year term</u>. Designated delegates may be re-appointed. One delegate shall represent each of the following departments: See proposed bylaws for list.
 - Item passed unanimously
- The proposed changes to section I. B (amendment 3): At large members shall be elected in August from the following areas and serve a <u>two-year term</u>. At large members may be re-elected.
 - Item passed unanimously
- The proposed changes to section I. B (amendment 4): Redistribution of total at large members to be elected: changed numbers are:
 - § Five (5) At-Large Members Professional Non-faculty
 - S Three (3) At-Large Members Secretarial/Clerical
 - § One (1) At-Large Member Skilled Craft
 - S One (1) At-Large Member Technical/Paraprofessional
 - S Five (5) At-Large Members Service/Maintenance
 - S One (1) At-Large Member Grant Funded
 - Item passed with a 20-2 vote
 - Will take nominations by email for new additions to above at large members
