A comprehensive exam must be passed during the semester in which the candidate plans to graduate.

**To apply for the three-year license: Wait until grades for the semester have posted to your transcript (check MyDSU). Send an email to [apowers@deltastate.edu](mailto:apowers@deltastate.edu) and CC [reacord@deltastate.edu](mailto:reacord@deltastate.edu) requesting verification for your three-year MAT license. Be sure to include first name, last name, 900#, major (elementary or secondary), and subject area.**
