<u>SWO320</u> Student's Weekly Volunteer Assignment

Each week a typed 2-page report in APA format regarding weekly volunteer activity is to be turned in on the Thursday following the completion of the work. At least 3 hours of volunteer experience is to be completed each week for 7 weeks for a total of 21 hours. The student should include a summary of the activities completed that week. In addition, the following information/activity is to be included in the weekly report during the week listed. Student should include their response (include feeling words) and critical thinking of experiences each week. The agency should have a social worker and be willing to let student complete lab assignments. Students are to learn to develop professional relationships characterized by mutuality, collaboration, and respect for clients.

- Week 1: Discuss the role of the social worker and the students' role in the agency. Discuss the services offered by the agency and the characteristics of service population. Who are you serving?
- Week 2: What are the eligibility requirements to receive services from the agency? What type of clients are served and what are the obstacles to receiving services at the agency? Discuss the resources used by the agency.
- Week 3: The student should observe an interview between the agency social worker and a client. Assess social work skills used and observation of use of social work values utilized by the agency social worker.
- Week 4: Sit quietly in the intake or waiting room and observe the atmosphere, conversations, and behaviors of persons entering the service delivery system as well as of those who serve them. Give your assessment of the clients and agency personnel.
- Week 5: The student should interview an agency client (with supervision of the social worker). Use this client to begin biopsychosocial assessment of client.
- Week 6: The student should go on a home visit (with the social worker or another approved agency person), preferably to a rural home.
- Week 7: Complete the biopsychosocial assessment of client.
