Actual Results of Evaluation

Grant awards decreased this year to \$4,184,742. There are several large grants that were not refunded this year for various reasons: 1) Teach for America grant from the Hearin Foundation was a one-time grant at \$1.8M; 2) Title III is in its fifth year of funding at \$400K; 3) Decrease or loss of funding for several CCED projects from \$875,992 to \$494,181.

The amount of external funding reported is not a true reflection of the external funds coming into the University. This amount does not include funding from the Teach for America contract.

Workshop #1: The First 80%

When: October 26, 2012

Where: Union 306

It is said that grantwriting is 80% research and 20% writing. This session will focus on the first 80% including locating and identifying both private and public funding opportunities, determining eligibility and capacity, understanding requests for proposals, and identifying stakeholders and potential partners.

Workshop #2: Justifying Your Need

When: November 30, 2012 1:00-3:30

Where: Jacob Conference Center, Ewing Hall

This workshop will focus on developing and writing the need justification section generally required in grant proposals. The session will cover defining institutional, community, and target population needs; exploring various sources of data to support the need; and tools to assess local need. Institutional Research and Planning (IRP) will provide information on utilizing internal institutional data in grant proposals.

Workshop #3: Program Development

When: January 25, 2013 1:00-3:30pm

Where: Jacob Conference Center

This workshop will focus on how you plan to address your need: what you are going to do and how you are going to do it. Participants will learn how to write effective goals, objectives, and anticipated outcomes and impact. Developing logic models, workplans, and timelines which convey to the funder the project activity details will be covered. DSU internal process for grant implementation will be discussed. While this workshop builds upon information covered in the previous two workshops, participation in them is not necessary in order to benefit from this workshop.

Workshop #4: Evaluation Planning and Design

When: Friday, March 22, 2013, 1:00 to 3:30 pm

Where: Union 306

Description: Evaluation is not just an activity that you do at the end of a project to report to the funder but instead should be an integral part of your project from its inception. This workshop will explore both qualitative and quantitative methods of evaluation, data collection and analysis, and the pros and cons of both internal and external evaluations. Various forms of survey instruments will be explored. The protection of human subjects and the IRB process will be discussed.

Workshop #5: Developing Your Budget








When: Friday, April 19, 2013, 1:00 to 3:30 pm

Where: Jacob Conference Center, Ewing Hall

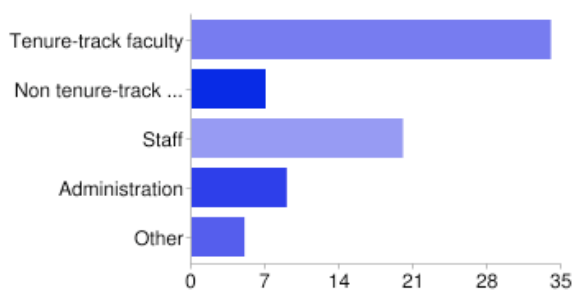

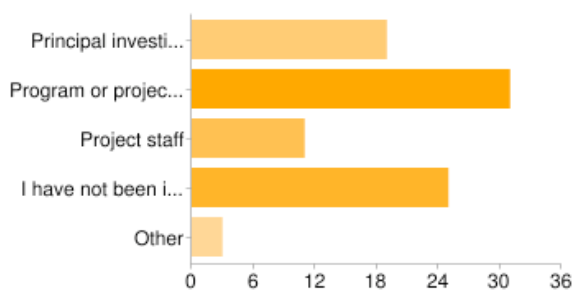
Which of the following describes your role in the University?

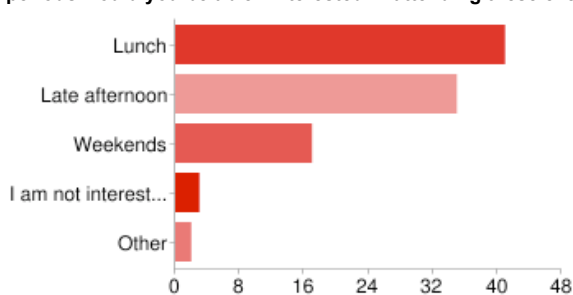
What role(s) have you played in the grant application process?

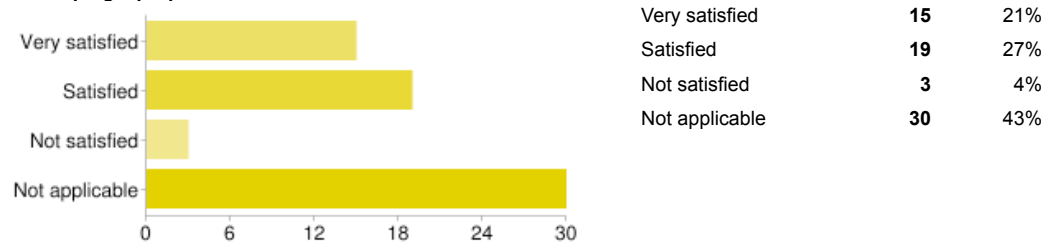
The grants office occasionally hosts brown bag lunches and workshops on topics related to grant funding. What times periods would you be able / interested in attending these events?



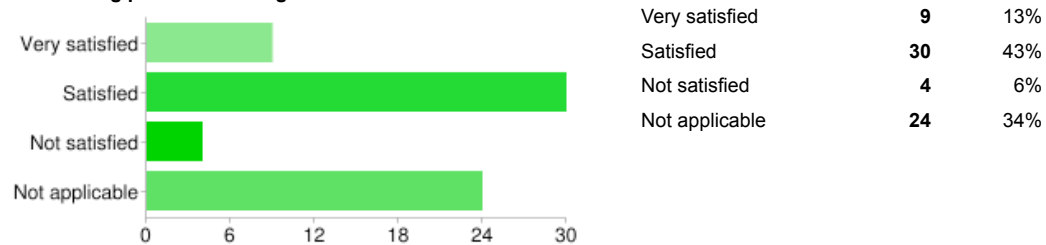

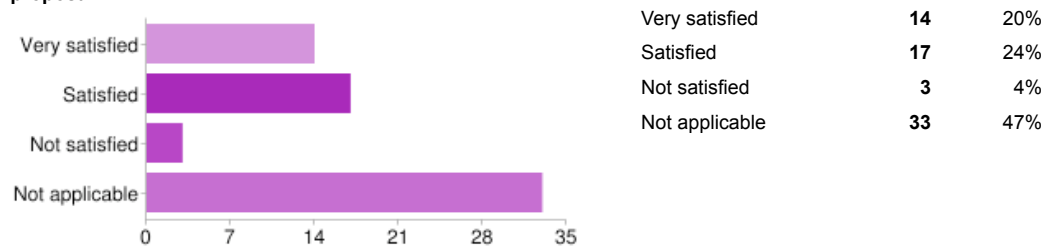
How satisfied are you with the following services related to proposal development? - Assistance with developing a proposal



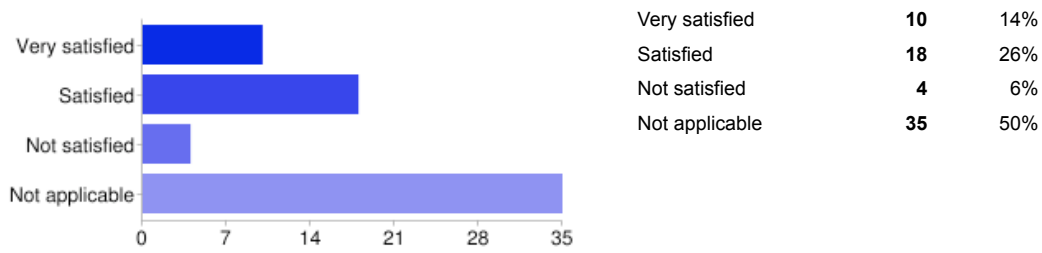
How satisfied are you with the following services related to proposal development? - Assistance with researching potential funding sources



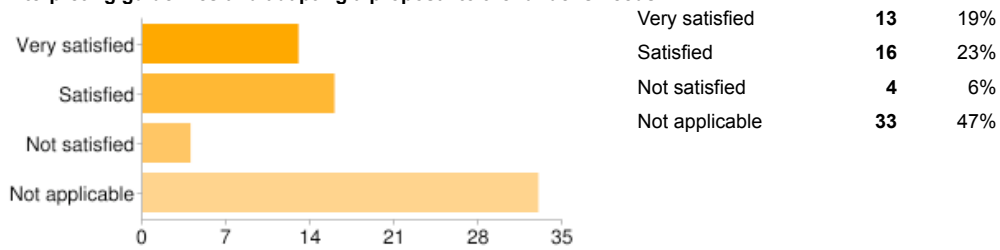
How satisfied are you with the following services related to proposal development? - Assistance writing a proposal



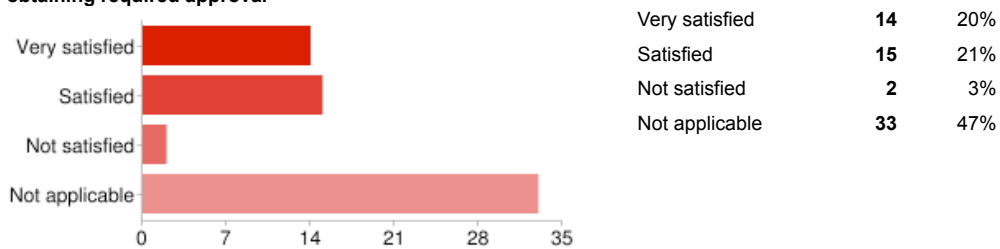
How satisfied are you with the following services related to proposal development? - Assistance editing a proposal



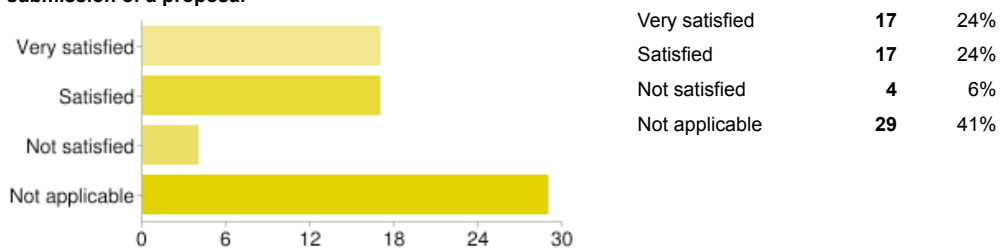
How satisfied are you with the following services related to proposal development? - Assistance interpreting guidelines and adapting a proposal to the funder's needs



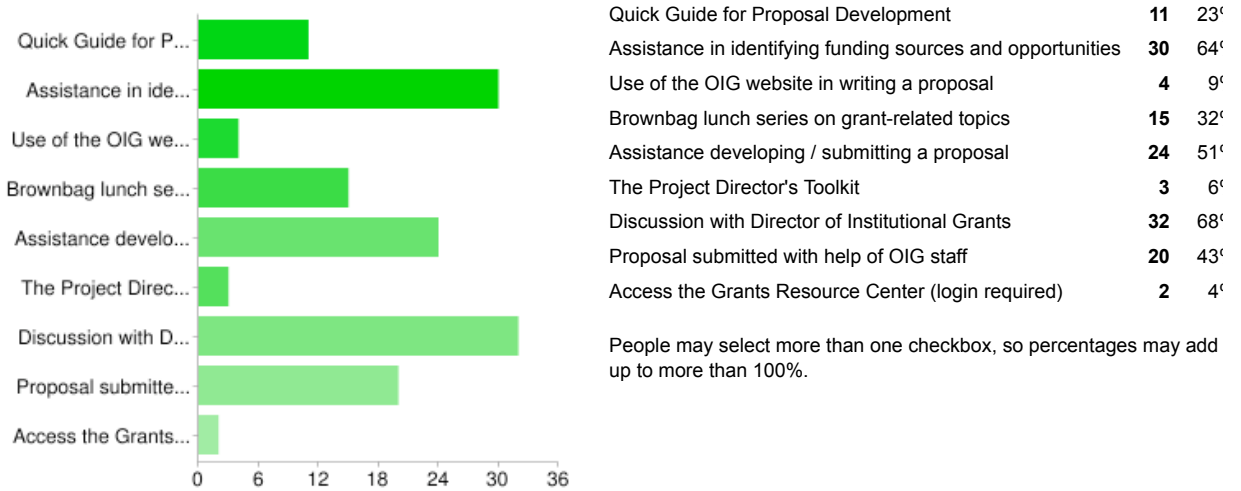
How satisfied are you with the following services related to proposal development? - Assistance in obtaining required approval



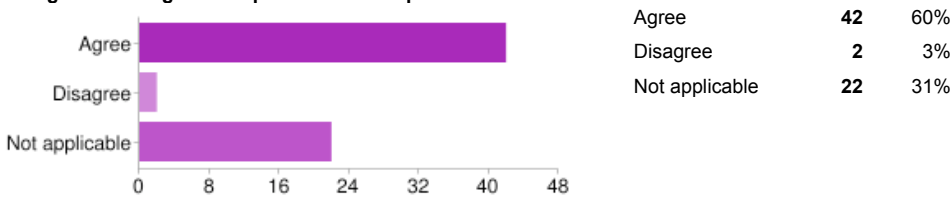
How satisfied are you with the following services related to proposal development? - Assistance in the submission of a proposal



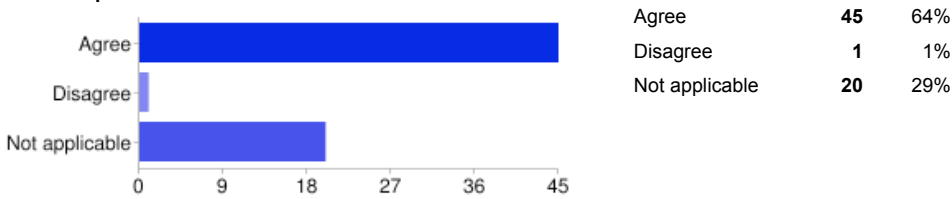
Which of the following services of the Grants office have you used?



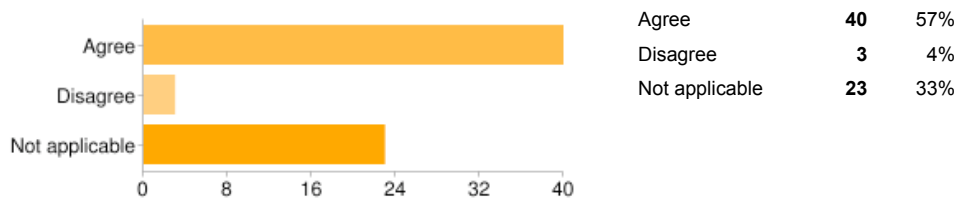

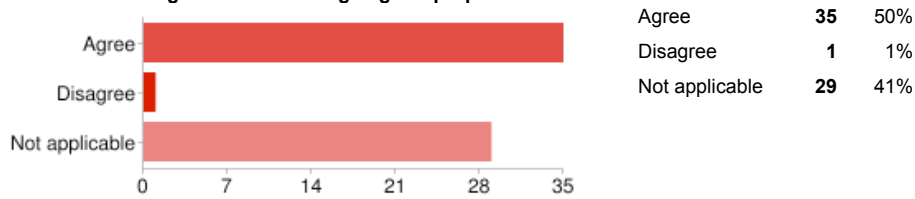
Please rate your experiences working with the Office of Institutional Grants. - The grants office staff exhibited professionalism.



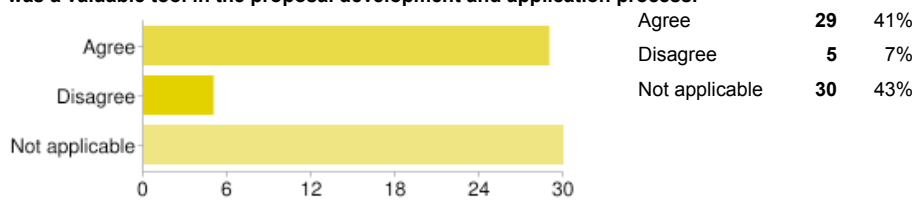
Please rate your experiences working with the Office of Institutional Grants. - The grants office staff were responsive to my needs



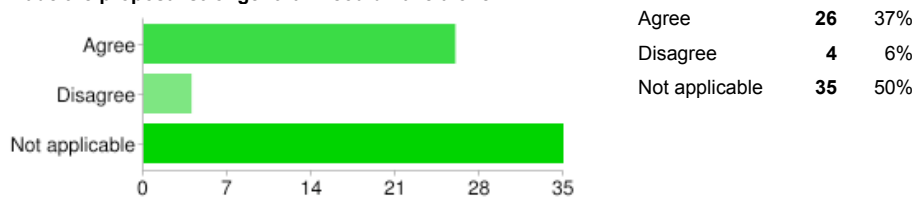
Please rate your experiences working with the Office of Institutional Grants. - The grants office staff were well organized and managed grant proposal deadlines well.



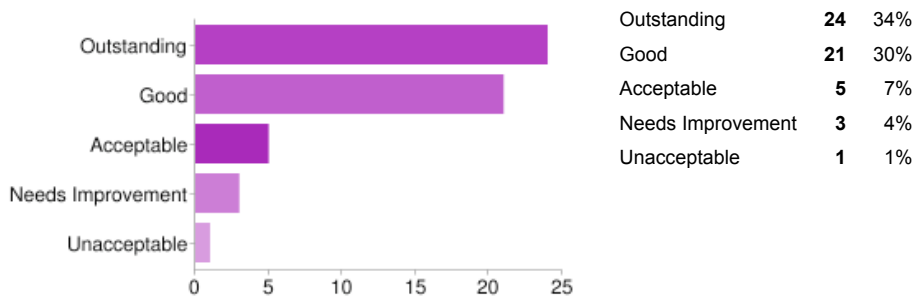

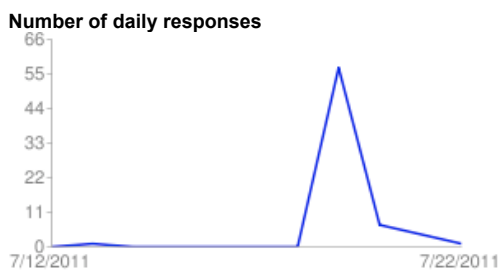

5. I'm new to DSU and have never submitted a grant at any institution. I am eager to learn and will be happy to attend workshops on any topic related. I am curious about: where to look for grants in my discipline, how to write them, what services are offered by DSU to assist in the process.
6. I think the focus needs to be on "What Direction Do We Go Now?" in response to the federal government and other agencies making proposed and actual cuts in funding current and future projects. Many of our projects rely on the federal government, but there must be other agencies and entities out there that can assist us - we just need some guidance on these possibilities; public, private, individual, corporate, etc.
7. I would like to see a grant program/workshop aimed specifically for the math and science disciplines - perhaps emphasizing pedagogical grants we would be competitive in obtaining. I think if this were offered as a series of lunchtime meetings in our building or as an extended faculty meeting on Friday afternoon, there would be good participation.
8. "A hands-on grant writing session. A time where you have already researched the grant you want to write but you haven't had time or the assisted guidance to fine tune it and really create a solid proposal.
Another great workshop would be one where grant applicants from various groups within towns or regions get together to see how they can collaborate on projects together. Collaborations seem to find better funding results than solo projects. Plus, if we are all doing sort of the same thing, we can pull those 'like' ideas together into one streamline product and get some serious funding perhaps!"



- ▶ Proposal Narrative
 - **Problem Statement or Needs Assessment**
 - Organizational Information/Partners
 - Goals and Objectives
 - Methods, Program Plan or Design
 - Evaluation
 - Sustainability
- ▶ Project Budget and Financial Information
- ▶ Appendices and/or Attachments

Problem Statement

A proposal must convince the prospective funder that a problem need of significant magnitude exists. It should be:

- ▶ based on objective research
- ▶ sufficient to demonstrate that a problem or need exists
- ▶ Stated in terms of your target population and community
- ▶ Specific to the reviewer/funder

Parts of the Need Section

- ▶ Identify and describe your target population
 - ▶ Provide a concise problem statement
 - ▶ Describe how your organization's mission fits with the problem statement and target population
 - ▶ Describe the social, educational, and economic impact of the problem
 - ▶ Provide evidence that the problem really exists and is severe enough for the funder to contribute resources

Data! Data! Data!

- ▶ Establish context for your funder and reviewers: national, state-level and local
- ▶ Never assume that a reviewer will know anything about the need in your target population
- ▶ Up-to-date data – no more than three year old data
- ▶ Cite sources
- ▶ Use tables, charts, graphs, bulleted lists
- ▶ Use credible letters of support, if allowed

Data Sources and Types

Data Sources

- ▶ Internal Sources: Information that is internal to your organization – IRP Data
- ▶ External Sources: Information outside your organization – Census, NCES
- ▶ Primary Sources: Data that you or your organization collected – Needs Assessment, Focus Groups
- ▶ Secondary Data Sources: Data that others have collected and published

Types of data

- ▶ Quantitative Data: Numbers, statistics
- ▶ Qualitative Data: Descriptive analysis
- ▶ Anecdotal Evidence: Personal Stories and experiences

From Math Science Partnership

- ▶ 74% of respondents reported being not adequately or only somewhat prepared in their understanding of the Common Core Math Standards.
- ▶ 59% reported only somewhat or less prepared in the understanding of the math concepts contained in the Common Core Math Standards (only 11% were well prepared or very well prepared)
- ▶ 56% indicated that they were only somewhat or not adequately prepared to provide mathematics instruction that meets the Common Core State Standards
- ▶ 44% felt only somewhat or not adequately prepared to select and/or adapt instructional materials to implement their curriculum
- ▶ 74% responded that they were only somewhat or not adequately prepared to teach mathematics to students who have limited English proficiency (only 4% felt very well prepared)
- ▶ 48% are only somewhat or not adequately prepared to teach students who have a learning disability which impacts mathematics learning
- ▶ 52% are somewhat or not prepared to teach reading in mathematics,
- ▶ 44% felt somewhat or not adequately prepared to provide quality intervention strategies

Clearly, the data indicates a need to assist teachers in enhancing their mathematics content knowledge and provide methods for them to do the same for the students that they teach.

Tips on Using Charts and Graphics

- ▶ Reserve tables for large amounts of information.
- ▶ Use bar and pie charts when you want to communicate age ranges by groups, income by groups, and numerical breakdowns of target population indicators.
- ▶ You can insert a credit line directly below each graphic, or you can insert footnotes. You can also use endnotes or a reference page.
- ▶ When the funder limits the number of pages you have to develop your narrative, try wrapping text around a graphic or typing text over a watermark graphic.
- ▶ Stay away from using clip art in your needs statement unless that's all you have.

Grantsmanship Defined

.....the art of acquiring peer-reviewed research funding

Successful grant applications depend on both the the quality of the program concept, science, or research methods, AND the quality of the grant application.

The Art of Grantsmanship

The art of "grantsmanship" will not turn mediocre science into a fundable grant proposal. But poor "grantsmanship" will, and often does, turn very good science into an unfundable grant proposal. Good writing will not save bad ideas, but bad writing can kill good ones. *Jacob Kraicer, University of Toronto*

Position Yourself as a Scholar

- Get engaged in your field
- Join professional societies
- Attend regional and national conferences
- Chair a conference session
- Write a literature review; can serve as the basis for a grant proposal
- Review for journals in your field

Position yourself as a Researcher

- ▶ Generate preliminary data – funders are risk averse.
- ▶ Use internal funds to establish data
- ▶ Present ideas at regional and national conferences
- ▶ Integrate research into teaching; think of them as one and not separate.
- ▶ Develop a long term research agenda
- ▶ Know where your research fits within the body of knowledge

Position yourself as a Grantwriter

- ▶ Review grants in your field
- ▶ Know who funds and who gets funded
- ▶ Know your competition! Who are the major players in your field?
- ▶ How does your research advance the field/literature
- ▶ Identify and position the right players – statisticians, co-investigators, evaluators, other institutions
- ▶ Team up with those with more capacity/experience

- ▶ Private Foundations
 - Community Foundation of Northwest Mississippi
 - Foundation for the Mid South

Regardless of type, funders are almost always mission-specific.

Commonalities

- ▶ Mission – specific
- ▶ Have guidelines established
- ▶ Has some method of format for requesting proposals
- ▶ Desires to award grants to fund programs

Delta State recently hosted 21 Delta-area, middle school science teachers at a 10-day, hands-on environmental science workshop. The Delta Environmental Education Project, funded by the Environmental Protection Agency (EPA), provided training, materials and resources on aquatic food webs.

Middle school teachers were selected from a pool of applicants from the region and received Continuing Education credits and a stipend for participation. An interactive website was developed to allow teachers to communicate and retrieve workshop materials as they prepare for the upcoming school year. Each teacher is eligible to receive a \$100 grant to buy classroom materials that will help them incorporate environmental science activities.

Teachers learned about a wide range of topics that included microbes, water quality, native and invasive species, local geology, regional flora and fauna, parasites, soil chemistry, composting, and the science curriculum. Special sessions included a tour of the U.S. Department of Agriculture (USDA) catfish facilities and an Adopt-A-Stream program.

The workshop was led by Delta State professor of Biology and Environmental Science Dr. Nina Baghai-Riding. Other faculty from the Division of Biological and Physical Sciences led sessions within the workshop, including Dr. Eric Blackwell (Ecology), Dr. Barry Campbell (Parasitology), Lacey Fitts (Curriculum & Community Gardens), Dr. Tanya McKinney (Microbiology), and Dr. Chuck Smithhart (Environmental Chemistry).

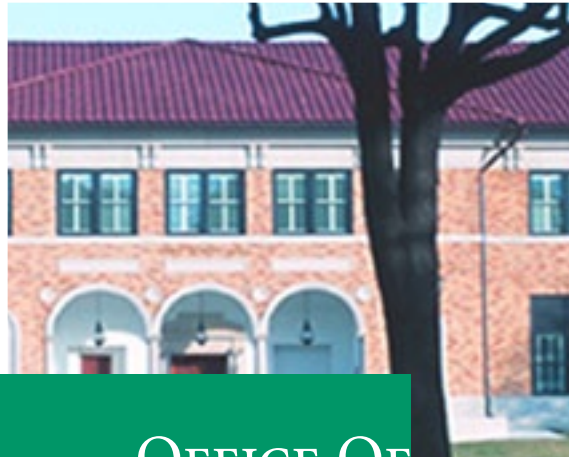
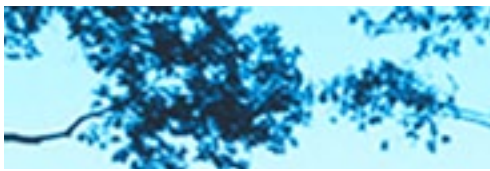
Evaluations of the workshop indicate that the teachers thoroughly enjoyed the workshop and came away with ideas and resources for incorporating environmental science activities in the classroom. A participant said the workshop exposed them to areas of science never before seen, allowing them to add new activities and content that will make science class more exciting. Other teachers reported an increase in awareness of local environmental issues and indicated how students can get involved in collecting meaningful data in the community.

This project was funded in part through an Environmental Education Regional Grant from the EPA. The EPA's purpose for this grant program is to increase public awareness and knowledge about environmental issues and provide the skills that participants in its funded projects need to make informed environmental decisions and take responsible actions toward the environment. The mission of the EPA is to protect human health and the environment.

The College of Education and Human Sciences at Delta State University has been awarded a \$924,000 Mathematics and Science Partnership Grant through the Mississippi Department of Education and U.S. Department of Education. The three-year Delta Math Science Partnership Initiative will target professional development for middle level mathematics educators, primarily in the Delta region.

Dr. Leslie Griffin, Dean of the College of Education and Human Sciences, in announcing the award, cited the need for additional training for teachers as they implement Common Core State Standards. “We are partnering with the Department of Mathematics in the College of Arts and Sciences, chaired by Dr. Clifton Wingard. Also committed to the project are a group of professional mathematics and science educators including Ms. Joyce McNair, Director of the Delta Area Association for the Improvement of Schools (DAAIS); Dr. Katharine Rasch, Unit Assessment Director for the College of Education and Human Sciences; and Mrs. Ann Huber, E-Learning Physics Teacher and Project Director. Each is distinguished in his/her respective field for not only strong content knowledge, but the ability to transfer this knowledge through creative and focused teaching strategies. This team will have primary responsibility for developing the curriculum for the project. The grant will also identify program faculty and coaches with expertise in the area,” said Griffin.

Area middle school mathematics teachers may apply to attend either of two initial institutes planned for June 2013, either the week of June 3-14 or June 17-28. Teachers who attend the training should expect to increase not only their depth of content math knowledge, but also skill in utilizing professional supports as vehicles for strong integrated lessons and improved math achievement. Total external support for Delta State University remains strong despite the struggling economy. The university recently reported external funding for fiscal year 2012 exceeding \$9 million.

The Delta State University Foundation received \$2.8 million in private support during FY2012, a 16% increase from a year ago. “The \$2.8 million in gifts and pledges for fiscal year 2012 represents the largest amount received in five years in the area of private support made through the Delta State University Foundation, Inc. We are very thankful to everyone who made a decision to financially support the University,” said Keith Fulcher, Executive Director of the Alumni and Foundation.

The Delta State University Foundation encourages and receives gifts and bequests for the university for restricted and unrestricted purposes. The Foundation also manages endowment funds and other private assets contributed for the benefit of the university. It provides funding for a diverse range of on-campus initiatives, including new construction and building renovation to academics to athletics.

External funding provides opportunities for students to have hands-on, real life experiences in programs such as our Center for Geospatial Informational Technologies, provides summer institutes for K-12 teachers, and allows the university to address issues such as suicide prevention, diabetes education, and healthy lifestyles, both on campus and in the community,” said Director of Institutional Grants Robin Boyles.

Delta State’s Office of Institutional Grants provides support to faculty and staff for securing external support from federal, state, and non-federal sources including foundations and corporations. The office maintains an official file of contracts and grants and reports all external funding to IHL and other entities as needed.

“As I conclude my tenth and final year as President of Delta State University I am pleased that a record-setting year in giving from all sources has been achieved,” said Delta State President Dr. John M. Hilpert.

The Delta State University Counseling and Student Health Center has been selected to receive a federal grant to address suicide prevention among the nation's college students. Delta State is one of forty universities and colleges nationwide that will participate in the Substance Abuse and Mental Health Services Administration grant project for the National Action Alliance for Suicide Prevention. The US Congress created the Garrett Lee Smith Memorial Act and the bill was signed by the President in October of 2004.

The Garrett Lee Smith Suicide Prevention Grant is scheduled for three years, totaling \$263,286. Delta State services an impoverished region of the country with higher rates of suicide attempts than the national average. Lack of community resources, rural isolationism, and state budget cuts are all factors that have created barriers in addressing suicide prevention on campus. This grant will enable Delta State to provide funding to address the six goals listed below.

This funding will allow Delta State, through its counseling center, to:

1. Train faculty and students using Kognito's At-Risk simulation training
2. Provide educational seminars on topics such as depression, suicide prevention and substance abuse
3. Promote the National Suicide Hotline
4. Provide information to parents
5. Develop and provide information materials that address warning signs
6. Strengthen its campus network and infrastructure to address the mental health needs of our students

Data from the university's Healthy Campus Initiative survey (2010) demonstrated several findings that indicated an increased need to address stress, depression, and suicide among college students. On a positive side, the findings also indicated that students are quite interested in receiving information and assistance in these areas. Monday, 10 September, the National Action Alliance for Suicide Prevention and the Office of the Surgeon General released the revised National Strategy for Suicide Prevention (NSSP). The Garrett Lee Smith grant will enable Delta State to be a contributing participant in this historic national strategy.
